Thank you for your letter of May 10, 2017 regarding the above matter.

I have reviewed the North Brunswick Municipal Court statistics data including but not limited to case filings and backlog percentages from 2012-2017. I have set forth below a summary of the same.

July, 2012 – June, 2013 - 27,265 filings cases	Backlog – 51% of the active pending cases
July, 2013 - June, 2014 - 23,789 filings cases	39% of the active pending cases
July, 2014 - June, 2015 - 25,066 filings cases	33% of the active pending cases
July, 2015 - June, 2016 - 30,474 filings cases	37% of the active pending cases
July, 2016 – May, 2017 - 31,116 filings cases	49% of the active pending cases

Pursuant to the current status of North Brunswick Municipal Court I hereby approve the appointment of a third judge to serve the North Brunswick Municipal Court.
